Firefighter Relief Fund

Experiencing financial hardship?

If you have exhausted your financial resources to pay for things like uncovered medical expenses, you may qualify for grant funds with no repayment requirements.

Fire Charities

Are you a charitable organization that supports fire departments and/or firefighter families?

Your organization may qualify for grant funds to help fulfill your mission of supporting the Fire Family.

College Scholarships

Is your child a high school senior or already enrolled in college?

They may qualify for a \$5,000 merit-based scholarship through Fire Family Foundation.

Disaster Relief

Are you a firefighter affected by a US federally declared disaster?

If you experienced a loss to your residence due to a major disaster, you may be eligible for emergency disaster support—including a \$250 Visa® card to help with immediate expenses.

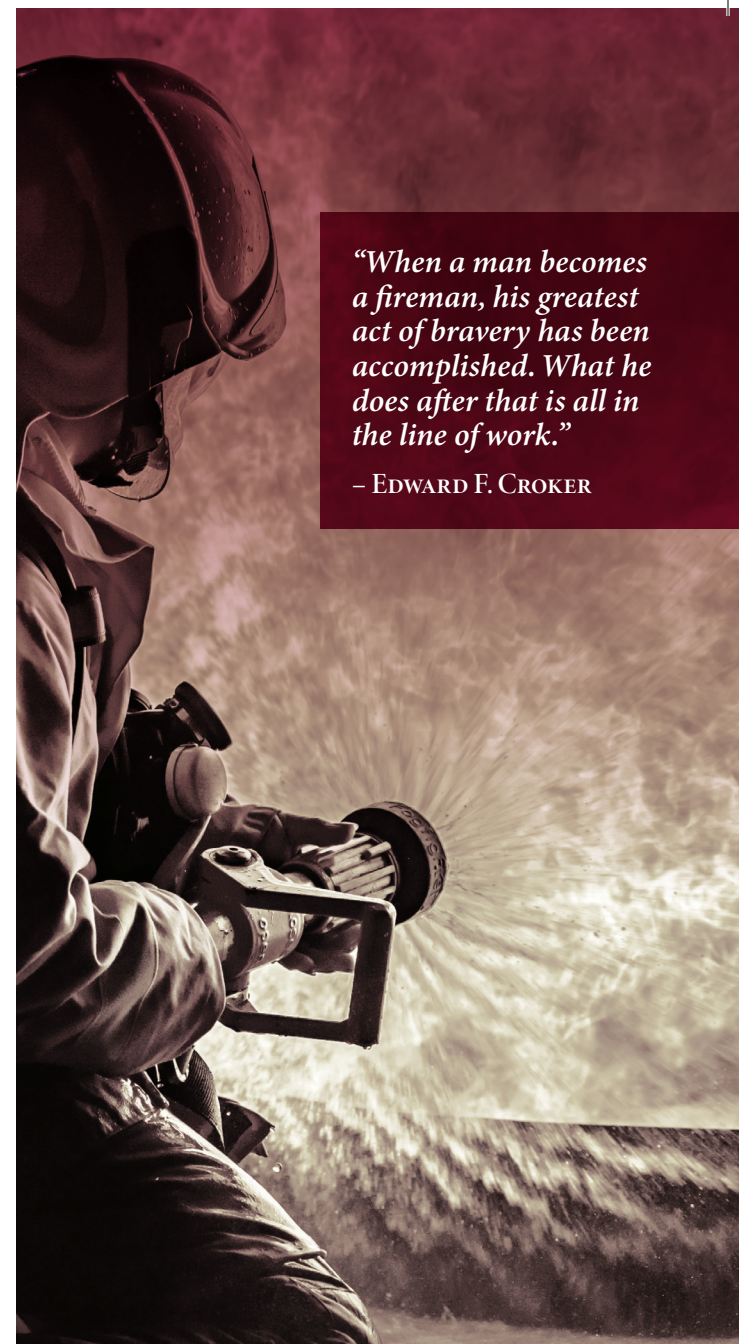

After 9/11, when 343 firefighters lost their lives, Firefighters First Credit Union received an outpouring of donations to support the New York City firefighting community.

The Credit Union was able to positively impact firefighters' families, inspiring Credit Union leaders to establish a non-profit foundation focused exclusively on serving the firefighting community.

We are dedicated to supporting the firefighters who risk their lives every day to protect our lives and property.

PROGRAMS

The Foundation provides support and financial assistance to firefighters and their families through four core programs.



Firefighter Relief Fund

We provide financial assistance to career and volunteer firefighters and their families nationwide who have exhausted their resources and are experiencing financial hardship.



Fire Charity Fund

We gift financial assistance to other 501(c)(3) tax-exempt organizations to support the local charitable needs of fire departments, firefighters, and their families.



Scholarships

We award ten \$5,000 merit-based college scholarships each year to the children of firefighters nationwide.



Disaster Relief

We offer financial assistance and emergency relief supplies, including blankets, toiletries, and more, to firefighters affected by US federally declared disasters.

Thanks to our continued partnership with Firefighters First Credit Union, which covers all of the Foundation's overhead costs, 100% of donations to the Foundation go directly towards our core programs.
